#### LAKEFRONT ESTATES COMMUNITY DEVELOPMENT DISTRICT REGULAR BOARD MEETING AND PUBLIC HEARING MARCH 27, 2024

#### A. CALL TO ORDER

The March 27, 2024, Regular Board Meeting of the Lakefront Estates Community Development District (the "District") was called to order at 12:20 p.m. in the Buckhead Ridge Community Building located at 30086 E. State Road 78, Okeechobee, Florida 34974

#### B. PROOF OF PUBLICATION

Proof of publication was presented which showed that notice of the Regular Board Meeting had been published in the *Lake Okeechobee News* on March 16, 2024 and March 13, 2024, as legally required.

#### C. ESTABLISH A QUORUM

A quorum was established with the following Supervisors in attendance:

Jason Weg, Matthew Meisels and Chaim Meisels.

Also in attendance were District Manager Andrew Karmeris of Special District Services, Inc.; District Engineer Steve Dobbs; District Manager Michelle Krizen of Special District Services, Inc. (via phone); District Counsel Wes Haber of Kutak Rock (via phone).

Also present were Mendal Lasker of Lightstone Management Group (via phone).

#### D. ADDITIONS OR DELETIONS TO AGENDA

There were no additions or deletions to the agenda.

#### E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

#### F. APPROVAL OF MINUTES

#### 1. February 21, 2024 Regular Board Meeting Minutes

It was noted that a typo was made to the publication date listed in the minutes and should have been February 7<sup>th</sup>, 2024.

A **motion** was made by Mr. Matthew Meisels, seconded by Mr. Weg and passed unanimously approving the minutes of the February 21, 2024, Regular Board Meeting, as amended.

The Regular Board Meeting was then recessed and the Public Hearing on the Levy of Non-Ad Valorem Assessments was opened.

#### G. PUBLIC HEARING – Levy of Non-Ad Valorem Special Assessments

#### 1. Proof of Publication

Proof of publication was presented which showed that notice of the Public Hearing had been published in the *Lake Okeechobee News* on March 16, 2024, and March 13, 2024, and mailed notice provided, as legally required.

#### 2. Receive Public Comment Regarding Intent to Levy Special Assessments

There was no public comment regarding the District's Intent to Levy Special Assessments.

#### 3. Consider Approval of Project and Levying of Non-Ad Valorem Special Assessments

Mr. Haber presented this item.

A **motion** was made by Mr. Matthew Meisels, seconded by Mr. Weg and passed unanimously approving the project and levying non-ad valorem special assessments.

## 4. Consider Adjusting and Equalizing of Non-Ad Valorem Special Assessments based on Comments from the Public

Mr. Karmeris explained that the Methodology Report approved in substantial final from the last meeting had no major changes other than a slight update of the engineering estimates and bond sizing.

A **motion** was made by Mr. Matthew Meisels, seconded by Mr. Weg and passed unanimously not adjusting and equalizing of non-ad valorem special assessments because there were no comments from the public and, based on the findings in the reports, the benefits received from the property to be assessed exceeds the burden imposed by the assessments and the assessments are fairly and reasonably allocated.

5. Consider Resolution No. 2024-04 – Authorizing the Project, the Intent to Levy Non-Ad Valorem Assessments, Intent to Utilize Chapter 170, 190 and 197, F.S., for the Levy, Collection and Enforcement of Non-Ad Valorem Assessments and Adoption of a Final Assessment Roll

Resolution No. 2024-04 was presented, entitled:

#### **MEMORANDUM**

TO: DISTRICT MANAGERS

FROM: KUTAK ROCK LLP - TALLAHASSEE

DATE: MAY 17, 2024

RE: RECENTLY ENACTED 2024 LEGISLATION

HB 7013—the 2024 special districts omnibus bill—has been signed by Governor DeSantis. As a result, special districts have new requirements and deadlines spelled out in statute.

#### Among other things the bill:

- Requires all special districts to adopt goals and objectives along with performance measures and standards to determine if a district has met its goals and objectives; this must be done by October 1, 2024. We encourage District Managers to prepare standardized draft goals and objectives to be adopted by district boards. Although some district boards may wish to establish more detailed goals and objectives specifically tailored to the activities of their particular district, the majority may wish to adopt standardized goals and objectives that are germane to special districts. Kutak Rock would like to review proposed goals and objectives prior to presentation to district boards.
  - Each subsequent year, an annual report must be prepared describing the goals and objectives achieved or failed to be achieved by the district, as well as the performance measures and standards used by the district to make this determination. The annual report must be posted on the district's website by December 1. The first of these annual reports is due **December 1, 2025.**
- Beginning with the 2024 elections, establishes a term limit of 12 years for members of a popularly elected body governing an independent special district, unless the district's charter provides for more restrictive terms of office. The term limits do not apply to community development districts created under Chapter 190, F.S., or an independent special district created pursuant to a special act that provides that "any amendment to chapter 190 to grant additional powers constitutes a power of that district."
- Allows the Department of Commerce to declare certain independent special districts (excluding community development districts) and community redevelopment districts

### KUTAKROCK

inactive if they report no revenue, expenditures, or debt for five consecutive years beginning no earlier than Oct. 1, 2018.

• States that independent special district boundaries shall only be changed by general law or special act. This language **does not apply** to a community development district established pursuant to Chapter 190, F.S.
